Monetta Young Investor Fund added to the New Mexico Scholar's Edge 529 Plan

In addition investors automatically earn tuition discount credits that can be applied to over 340 private colleges and universities nationwide and can participate in an interactive education program that encourages kids to learn basic money skills that can last a lifetime.

"The tax benefits of a 529 saving plan combined with an investment in the Monetta Young Investor Fund gives families an edge toward investing for college" says Robert S. Bacarella, Monetta's President and Portfolio Manager. "This is an innovative and distinctive fund option that encourages the whole family to get involved in a college savings process."

A 529 plan is a tax-advantaged investment vehicle designed to encourage saving for future higher education expenses. The plan allows an account holder to establish a college savings account for a beneficiary and use the money to pay for tuition, room and board, mandatory fees and required books and computers. Earnings are not subject to federal tax (and state tax, in most cases) as long as the money is used only for qualified college expenses.
